On August 13, 2021, three seatbelt retractors with out of specification ALR levers were tested in vehicle. It was confirmed that one of the ALRs deactivated earlier than intended and may not meet the FMVSS 208 S7.1.1.5 requirement.

On September 2, 2021, the Vehicle Regulations Committee decided to proceed with a recall action for the affected vehicles for safety noncompliance with FMVSS 208.
